Volume No. 4, pages 8485 to 8501 being no. 03332 for the year 2010 (Artist Circle (Run by Artists Welfare Trust) 46, Circus Avenue, Kolkata-700017, Phone-22833176, Web : artistscircle.co, Email - artistcircle.gallery@gmail.com).

AND WHEREAS a meeting was held on Saturday the 10th of July, 2010 at the "**ARTISTS CIRCLE PREMISES**" 46, Circus Avenue, Kolkata-700017 at about 5.00 P.M. wherein the aforesaid settler & Trustees decided to amend or alter schemes, rules & regulations and by laws accordingly they decided to incorporate the terms with the existing deed being no. 03332 for the year 2010 as under.

1. Vide Clause No. 10 of the original deed; a third trustee to be admitted whose name is Papiya Mukherjee wife of Shri Kamal Mukherjee a retired principal, residing at 108/A, Dr. A.K. Paul Road, Behala, Kolkata-700034.
2. Vide clause no. 9m to incorporate the following by laws :-
 - 2.a. To promote International peace Harmony friendship through art and cultural activities and exchange programs.
 - b. To give necessary relief in ways required, to the affected areas in times of flood, famine, pestilence and other calamities caused by nature.
 - c. To improve the social and cultural life of the people by organizing various functions social and cultural function from time to time.
 - d. To make the physically and mentally challenged children critically aware about their surroundings and to help them overcome the limitations and constraints under which they live by way of cultural activities.
 - e. To undertake schemes/ projects and programs for providing opportunities by community participation, leadership and human resource development and mobilization of local resources among the people.
 - f. To promote exchange of visual and non visual sensibilities among Indians and other countries all over the world.
 - g. To act as a center for training, coordination and implementation of development programs for the up-liftmen of the poor and marginalized and the backward and minority communities for the improvement of their social economic and cultural life aiming at sustainability.

To extend support by way of technological intervention, marketing, welfare and financial intervention to craft workers so that they may carry out their creative activities. Support them by giving place to exhibit and display their products in different places in India and abroad. Also help to procure orders for handicraft produces by them Organize fairs and Melas to display their works. Provide support related to health, hygiene, and education in general towards social up-liftmen.
- i. To work for gender justice and development especially for the women artisans and poor children.
- j. To organize training programs in terms of education such as computer training and short courses, for poor students.
